



CHARTER PASSENGER WAIVER

(Form for Adults)

1. I wish to participate as a passenger on the recreational charter boat ride being operated by American Dream Charters, LLC (the "Charter"), and I acknowledge that my participation in the Charter is completely voluntary.
2. **I UNDERSTAND THAT THERE ARE INHERENT RISKS INVOLVED WITH BOATING**, including, but not limited to equipment failure, perils of the lake, harm caused by other vessels, acts of fellow participants, swimming, entering and exiting the water, boarding or disembarking boats, and activities on the docks.
3. I fully assume responsibility for my own safety (including, without limitation, following all directions of the boat's captain and crew) while participating in the Charter, and verify that I am physically able to participate.
4. I fully understand that the involved boat has limited medical facilities and that in the event of illness or injury appropriate medical care must be summoned by radio and treatment will be delayed until I can be transported to a proper medical facility. I agree in advance to these conditions.
5. No person associated with American Dream Charters, LLC has made any express or implied representation to me that they or the boat's crew can or will perform safe rescues or render first aid. In the event that I show signs of distress or call for aid, I would like assistance and will not hold any person or entity responsible for their actions in attempting the performance or rescue or first aid.
6. Having read this waiver, I agree to **RELEASE** from **LIABILITY** and **HOLD HARMLESS** American Dream Charters, LLC along with its respective officers, directors, employees, owners, members, managers, affiliates, agents, representatives, attorneys, heirs, personal representatives, successors and assigns, all individuals associated with the Charter, and all individuals and entities having an interest in the boat being used for the Charter, from any and all liability, claims, demands, equitable relief, damages, costs, expenses, and causes of action of any kind or character, of any type or nature whatsoever (including negligence), arising out of the Charter.
7. I authorize American Dream Charters, LLC to use any photographs, personal narrative, interviews, or audio and video recording of my participation in the Charter for any and all purposes.
8. **CUSTOMER/GUEST BEHAVIOR** - Customers and guests are expected to conduct themselves in an appropriate manner. Inappropriate behavior will not be tolerated. Any behavior by the Captain to be inappropriate (lewd, offensive, unsafe, etc.) may result in a non-refundable, early termination of your charter.
9. **WEAPONS ARE STRICTLY PROHIBITED** - Weapons of any kind are strictly prohibited! Guns, knives, or weapons of any kind are NOT allowed on board our vessels at any time. Bringing any of these prohibited items aboard may result in a non-refundable, early termination of your charter.
